9:00 AM - CALL TO ORDER AND PLEDGE OF ALLEGIANCE

The regular meeting of the Columbia County Board of Commissioners was held on June 1, 2026, with Chairman Ryan R. Rundell, Commissioner Jack G. Miller, Commissioner Marty J. Hall, Clerk of the Board Virginia Schmidt present. List of attendees is attached.

9:00 AM - PUBLIC COMMENT SESSION

Time was allowed for public comment. No public comments were made or taken.

9:10 AM - COLUMBIA COUNTY FINANCE COMMITTEE

Carla Rowe and Sadie Gregg were present as the Finance Committee. A first quarter finance review was given. No action was taken.

9:30 AM - COLUMBIA COUNTY HUMAN RESOURCES

Ashley Kilts discussed the upcoming need to adopt policies and procedures for AI use. Future discussions will be held.

Ashley held a brief discussion regarding correcting the wage scale placement of the legal intern, adjusting the scale on the job description. An adjustment was made from level 4 to grade 11, step 6.

Commissioner Miller moved to approve the legal intern salary to be set at grade 11, step 6. The motion unanimously carried.

A discussion was held regarding the county vehicle use policy, specifically take-home vehicles. The policy will be updated to include guidelines and procedures for a take-home vehicle for specific positions.

A public hearing was held at 10:00 am, to discuss the proposed plan to surplus the building at 215 E Clay. The meeting was briefly paused/recessed to continue a discussion with HR.

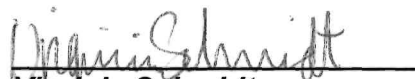
***Commissioner Hall moved to adopt Resolution #2026-11 in the matter of
