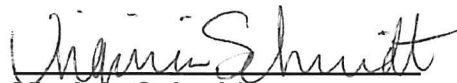
**12:00 PM - BREAK FOR LUNCH**

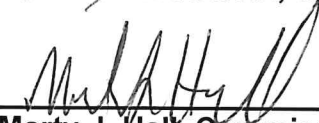
