**9:30 AM - COLUMBIA COUNTY AUDITOR**

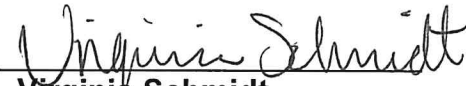
Jann Manwell was present to review the 2023 preliminary budget for the Auditor's office.

**MISCELLANEOUS**

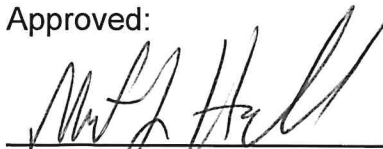
The Board discussed COLA increases for county employees and the Auditor will run comparison reports to finalize numbers.

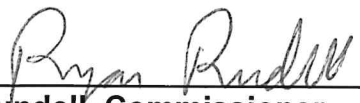
