A discussion was held regarding selling the previous Emergency Management Directors vehicle. The truck is no longer needed and the proper procedures will be taken to sell the vehicle.

The Board reviewed the job description of the professional employment recruiter. A change in the salary schedule will be needed to add a temporary, part-time line.

Commissioner Rundell moved to approve the job description for a professional employment recruiter, as presented. The motion unanimously carried.
