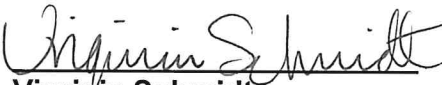
MISCELLANEOUS

The work session scheduled for September 11, 2023 will be held at 12:30 pm to accommodate an afternoon session for union contract negotiations.

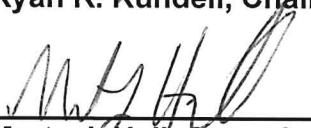
Treasurer Carla Rowe informed the Board that Columbia Pulp had been sold and has requested to waive the interest accrued.

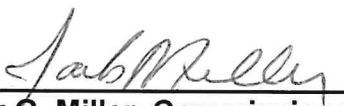
There being no further business to come before the Board, the meeting was duly declared adjourned at 10:13 am.
