Commissioner Amerein moved to join the Washington Rural Counties Insurance Program. The motion unanimously carried.

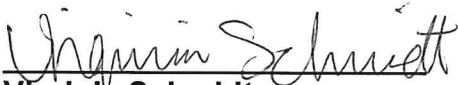
9:01 AM - EMERGENCY MANAGEMENT

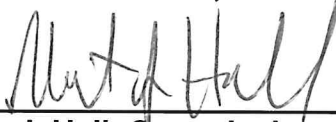
