Commissioner Hall updated the board with citizen concerns about the crosswalk in front of the County Office Building. He is in contact with the city about possible resolutions.

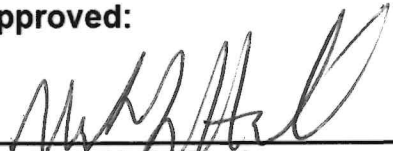
There being no further business to come before the Board, the meeting was duly declared adjourned at 11:40 am.

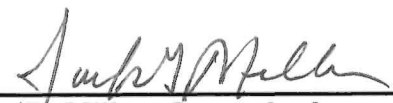

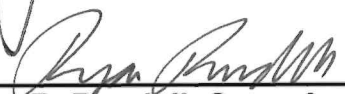
